1. The reporting trustee has filed this change report, under the provisions of Sec. 22 of the B.P.T. Act 1950.
2. It is contention of the reporting trustee that, new management committee has been elected for the period commencing from 2015 to 2020. The reporting trustee wants to record this change in PTR of the trust. Hence, this change report.
3. In pursuance of the order passed below Exh.01 regarding issuance of notice to the outgoing trustees, the outgoing trustees viz. Shailendra Mehta, Vinod Mahindrakar and Pramod Dandavate appeared suo-moto and filed their affidavits at Exh.12 to 14 respectively and consenting to the change report. No one has objected to this change report. Hence, this change report is uncontested one.
4. Delay caused in filing change report has been condoned by this Authority vide order below Exh.04.

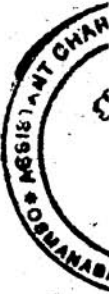
- : REASONS :-

6. The reporting trustee relied upon documentary as well oral evidence. Consent letter and No-objection of the trustees are at Exh. 02 & 03 respectively. Certified copy of Exh.01 in Inq. No.91/11 is at Exh.04, certified copy of Judgement in Inq. No.91/11 is at Exh.04-A, certified copy of Scheme is at Exh.05, certified copy of PTR is at Exh.06. The copy of Notice dated 28/06/2015 issued for the purpose of calling Annual general body meeting on 29/06/2015, is at Exh.17. The copy of minutes of meeting of general body dated 29/06/2015 is at Exh.18. Copy of membership register is at Exh.18-A. The reporting trustee adduced his oral evidence by way of affidavit-in-chief Exh.20. Lastly, reporting trustee closed his evidence by filing pursis at Exh. 19.

7. As to Point No. 1

8. The reporting trustee Pravin Kale has deposed vide Exh.20 that, the new managing committee has been elected in the general body meeting dtd.29/06/2015 for the period commencing from 2015 to 2020.

9. The perusal of the proceeding book vide Exh.18, reveals that by virtue of Resolution No.03 the new management committee has been elected for the term commencing from 2015 to 2020. As per the provisions contained in Art.16 of the rules and regulations of the trust, the new executive committee is to be elected in the general body meeting after the period of every 5 years. From the contents of the

minutes of the general body meeting dt. 29/06/2015 it transpires that, the members of executive committee are elected in the said general body meeting. The documentary evidence and oral evidence of the applicant is corroborative to each other. The evidence adduced by the reporting trustee has remained unchallenged as no one has cross-examined the witness or objected to the change report. Hence, there is no reason to disbelieve the evidence of the reporting trustee.

10. The structure and the strength of this managing committee is same as shown in the constitution of the trust. It means that, the change mentioned in the change report Exh.1 is legal and valid.

11. Thus, taking into consideration the above things, the change occurred in the trust is legal and valid and such deserves to be recorded Schedule - I of the trust. Hence, I answer Point No.1 in the affirmative and proceed to passed following order.

:- ORDER :-

1. The change, reported in inquiry No. 09/2016 at Exh.1, is hereby accepted.
2. Schedule-I of the trust be amended accordingly.
3. No orders as to costs.

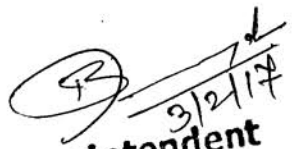
